Solanaceae - Tomatoes, peppers, capsicums	2 L	3	- First flower - 10-15 days after 1st application - 10-15 days after 2nd application
Leafy vegetables - Celery, lettuce, spinach, brassicas	2 L	3	- After planting out - 10-15 days after 1st application - 10-15 days after 2nd application

Directions for use :

- shake well before use
- pour Goëmar BM START last in the tank
